

Call for expert applications for the Editorial Board of the Journal SINAPPSI

1. Purpose of the assignment

The present Call for Applications seeks to find experts, with proven and consolidated scientific competencies in the topics below, to independently work as members of the Editorial Board for the journal SINAPPSI.

The areas of expertise required are the following:

- analysis of the economic dynamics of the labor market;
- analysis of the legal and social aspects of the labor market;
- analysis of welfare systems and industrial relations;
- analysis of labor policies;
- analysis of public policies and their implications for the labor market, income distribution, social and territorial cohesion and inclusion.

INAPP may appoint a maximum of 15 experts in the Board and will do so according to the selection process specified herein.

2. Role requirements and remuneration

The appointment as a member of the Editorial Board for the journal SINAPPSI, once conferred, will be effective for 24 months, unless revoked earlier.

The appointment will be effective on the date of signing of the collaboration contract which stipulates the mandate of the assignment.

The Institute may terminate the collaboration agreement at any time, at its sole discretion, with formal notice of not less than 15 days. In this instance, the compensation accrued until the date of communication of contract termination will be paid, without providing any further indemnity, compensation and/or damages.

The total compensation provided for this assignment is equal to € 5,000 gross on an annual basis and net of any VAT and any eventual further financial contribution by INAPP.

The recipients of the above will be entitled only to the compensation as defined in the collaboration contract.

The payment will be disbursed within 30 days from the date of submission of the remuneration note or electronic invoice, which every semester will be presented by the interested party to the President of the Institute, Prof. Sebastiano Fadda, as Editorial Director of the magazine SINAPPSI, for authorization, according to the modalities that will be made known on the occasion of the stipulation of the collaboration contract.



3.Admission requirements for selection, evaluation and preference criteria

General Eligibility Requirements:

Each applicant must, in order to participate in the relevant comparative selection process, send, in the manner indicated below, an expression of interest in which he/she claims to be in possession of the following requirements:

- not to have been found guilty of definitive criminal convictions or convictions or measures that prevent, per the provisions in force, the establishment of a relationship of collaboration with the Public Administration:
- not being in any of the situations of conflict and/or incompatibility provided for by Legislative Decree no. 39/2013 and subsequent amendments and additions;
- not to have been dismissed or disqualified from employment with a Public Administration and/or private entity required to comply with public regulations for persistent inadequate performance or dismissed following disciplinary proceedings or for falsifying documents or providing documents containing faulty information;
- not to be in a situation of conflict of interest.

He/She must also expressly declare to have read and understood the content of the Information on the processing of personal data provided to applicants applying for freelance positions at INAPP under Article 13 of EU Regulation 2016/679, as reported in the Privacy Annex to this Public Notice.

Having considered the eligibility requirements listed above, the selection process will be made according to the following evaluation and preference criteria:

Evaluation criteria:

- experience (not less than five years) in teaching or research in an academic area relevant to the areas of research mentioned in paragraph. 1;
- scientific publications (not less than five) in ANVUR-ranked journals;
- experience in peer-review evaluation of scientific publications;

Preference criteria:

- Be a member of other editorial boards of scientific journals surveyed by ANVUR;
- to have published in English-language journals;
- have carried out university teaching assignments at foreign universities on the topics referred to in paragraph 1.
- have explored, in publications, research and teaching, issues related to public policies on labor market, human capital, social inclusion and welfare;



- have demonstrated critical skills about different schools of economic thought, including the so-called "mainstream", capacity of original elaboration, mastery in the field of macroeconomic issues and the economic role of the State;
- be part of scientific communities and research networks at both national and international level;
- possess initiative, planning, and leadership capacity in the field of scientific research.

Application form

Applicants interested in taking part in the selection process must send an e-mail to INAPP (presidenza@inapp.org) by no later than 1 pm on the 11th of October 2021, no exception allowed.

The applicant should indicate in the subject of the e-mail the relevant position he/she is applying to and include name and surname.

The Institute does not take any responsibility in case of e-mail communications containing expressions of interest that have files attached that are damaged or cannot be opened by the Institute's information system; such communications will be dismissed.

The e-mail from which the applicant forwards his/her expression of interest will be used for potential future communications by the Institute for information regarding the selection process.

Expressions of interest, in addition to the information specified in paragraph 3 above, must include, as an attachment, an updated curriculum vitae, duly dated and signed, which exhaustively shows the skills and professional experiences of the applicant, relevant to the evaluation and preference criteria listed above. Please also attach a copy of a valid ID, signed at the bottom.

Each application will be examined by a special Technical Board, chaired by the Editorial Director of the journal SINAPPSI, which will preliminarily verify, based on the curricula and documentation submitted, the possession of the requirements/criteria listed above.

Expression of interest will only take place following the instructions above. Any other form of communication will result in the exclusion from the selection process.

The Institute reserves the right to conduct appropriate checks on the truthfulness of the information provided by the applicant in the expression of interest and the CV.

After the examination of CV, the Technical Board may convene, where necessary, the candidates for an interview regarding their experiences.

In compliance with Legislative Decree no. 196/2003 and subsequent amendments and the EU Regulation 2016/679, the data contained in each application will be used only to carry out the selection process relative to this specific Call for Applications.

5. Processing of personal data
